General Understanding

- **Purpose of Gift.** Any gifts are irrevocable and will be used to provide general funding for development, construction and maintenance of an arena facility in Crookston, Minnesota. The arena will be used for ice hockey and public skating and will have spectator seating features, with two practice rinks, walking track and dry land training space. Priority will be facility construction, but funds may also be spent on facility equipment, related systems and amenities.
- **Reliance.** This gift/pledge, and those of others, will be relied on by the City of Crookston to determine final project scope and budget.
- **Acceleration of Payments.** Donors may accelerate payment on this commitment at any time.
- **Recognition.** Any public recognition or announcement of Donors' contribution and involvement in the campaign shall be coordinated between Donors, the Crookston Arena Project Committee and Northwest Minnesota Foundation prior to the announcement.
- **Termination of Commitment.** Donors will make every effort to fulfill this commitment; however, Donors reserve the right to terminate this commitment if financial

circumstances change significantly. Such action may result in the loss or removal of any public recognition that had been awarded.

- **Relationship to the Northwest Minnesota Foundation.** The Crookston Arena Project is a component fund of the Northwest Minnesota Foundation (NMF). NMF is a 501(c)(3) charitable nonprofit organization, and all gifts to the Crookston Arena Project qualify as charitable contributions to the extent allowed by law.
